1. The Case Law Conclave - National IP Challenge



The *Case Law Conclave* is a stimulating competition that challenges participants to dive deep into complex IP cases. Each team will analyse assigned cases, identify legal issues and propose well-reasoned solutions. This competition emphasises analytical thinking, research prowess and presentation skills, making it ideal for those interested in legal problem-solving.

Rules & Regulations

- **Team Composition:** Teams may consist of maximum 2 members.
- **Case Distribution:** IP cases will be distributed 48 hours before the competition, allowing participants adequate time for research and analysis.
- **Submission Format:** Teams are required to submit a report (maximum 2000 words) summarising their analysis and proposed solutions. This report will be followed by a presentation.
- **Presentation:** Each team will have 10 minutes to present their findings, followed by a 5-minute Q&A with the judges.

Evaluation Criteria:

- **Case Analysis:** Depth of understanding of the legal issues involved (20%)
- **Solution Quality:** Creativity, feasibility and practicality of proposed solutions (30%)
- **Legal Reasoning:** Use of relevant laws, case precedents and structured arguments (30%)
- **Presentation Skills:** Clarity, organisation and audience engagement (20%)

2. Patent Blueprints Battle - National Patent Drafting Competition



Patent Blueprints Battle is a National Patent Drafting Competition where participants will draft patent applications based on hypothetical inventions. This contest is an opportunity to gain hands-on experience in patent drafting, requiring an understanding of both technical specifications and legal language.

Rules & Regulations:

- **Team Composition:** Participants may enter as individuals or in teams of 2 members.
- **Invention Details:** Descriptions of hypothetical inventions will be shared 24 hours before the competition, allowing time to understand and draft appropriate patent claims.
- **Submission Requirements:**
 - Patent claims (not exceeding 1500 words)
 - Detailed description, abstract, and drawings (if applicable)

- **Invention Description:** Completeness and comprehensiveness of the invention's description (25%)
- **Technical Accuracy:** Proper use of terminology and accurate representation of the invention (20%)
- **Legal Compliance:** Adherence to patent laws and standards (15%)
- **Creativity:** Innovative approach to covering the invention's scope (15%)

Eligibility: Open to students and professionals in law, engineering or science.

Documentation: Participants must submit ID proof and a resume detailing relevant coursework or experience.

- **Team Composition:** Participants may enter as individuals or in teams of 2 members.
- **Design Brief:** Briefs on fictional companies will be provided at the start of the competition to guide the design process.
- **Submission Format:**
 - Logo design in digital format (JPEG or PNG)
 - A brief explanation of the concept and brand identity (max 300 words)

Evaluation Criteria:

- **Creativity:** Originality and uniqueness of the design (30%)
- **Brand Representation:** Effectiveness in conveying the intended brand identity (30%)
- **Practicality:** Scalability, colour choices, and clarity of the design (20%)
- **Trademark Law Compliance:** Avoidance of generic, descriptive, or infringing elements to ensure compliance (20%)

Participation Requirements:

Eligibility: Open to students and professionals in law, design, or marketing.

Registration Fee: Rs. 200 per individual/team.

Submission Requirements: Each design must be submitted digitally in JPEG/PNG format with an accompanying description.
